Declaration**

Notice of Appeal is herein given by Defendants Beverly Hill, Darrell Hill, individually and together doing business as Superior Claims Management in the above named USDC case [CV 05-0877 DGC PHX (9th USDC, D. Ariz.)].

The Defendants' filed a Rule 59 and 62 motion with the USDC for the amendment of the USDC Order and Final judgment (Doc. # 193) which was denied. See [www.getmytaxesback.com](http://www.getmytaxesback.com) webpage for case docket data.

The Court's Order and equivalent Permanent Injunction: 1) fashioned Defendants to be "federal tax return preparers [undoubtedly fashioned from the IRC term "income tax return preparers" (IRC § 7701(a)(36)]; 2) ignored Defendants' contractual Fiduciary [IRC § 7701(a)(6)...(36)(B)(iii)] obligations; and 3) crafted other corroborating items of injunction equally repugnant to the Constitution for the United States of America and denying Defendants (and Defendants' Beneficiary) inalienable rights and equal protections under the Constitutions of the State of Arizona, the Law of the land, and promulgated statutes and regulations. (As a direct result of the USDC order the Defendants' Beneficiary are now reporting to Defendants a disturbing pattern of systematic threats and abuses from Department of the Treasury/ Internal Revenue Service (DotT/IRS) employees corroborating well known collection violations against the inalienable rights of the Defendants' Beneficiary.)
